BLACKICE FORM FILLER END USER LICENSE AGREEMENT

BY CHOOSING THE "IACCEPT THE TERMS OF THE LICENSE AGREEMENT" OPTION OR OPENING THE PACKAGE, YOU ARE CONSENTING TO BE BOUND BY THIS AGREEMENT. IF YOU DO NOT AGREE TO ALL OF THE TERMS OF THIS AGREEMENT, CHOOSE THE "I DO NOT ACCEPT THE TERMS OF THE LICENSE AGREEMENT" BUTTON AND THE INSTALLATION PROCESS WILL NOT CONTINUE OR RETURN THE PRODUCT TO THE PLACE OF PURCHASE FOR A FULL REFUND.

<u>SCOPE</u>. This Agreement establishes the terms and conditions governing the use of Black Ice Form Filler (the "**Software**") developed by Fax Products LLC (the "**Licensor**") and licensed by the END USER (the "**Licensee**".)

<u>LICENSE GRANT</u>. In consideration of the license fees paid and subject to the terms and conditions of this Agreement, Licensor grants to Licensee a worldwide, non-exclusive, non-transferable, limited license to use the Software and accompanying documentation ("Documentation") in the manner described below under "Scope of Grant."

SCOPE OF GRANT

Licensee may:

- use the Softw are for the purpose of evaluating whether to purchase an ongoing license to the Softw are. The evaluation period for personal use or use by or on behalf of a commercial entity is limited to 15 or 30 days.
- use the Software strictly in compliance with the purchased license(s);
- use the Softw are on a network, provided that each person accessing the Softw are through the network must have a copy licensed to that person:
- copy the Softw are for archival purposes, provided any copy must contain all of the original Software's proprietary notices; or if Licensee have purchased multiple licenses, the number of copies is the total number of copies that may be made for all platforms. Additional copies of Documentation may be purchased.

TERMS APPLICABLE TO ALL LICENSE GRANTS.

Licensee may not:

- permit other individuals to use the Softw are except under the terms listed above;
- permit concurrent use of the Software unless otherwise granted by the license(s);
- modify, translate, reverse engineer, decompile, and disassemble (except to the extent applicable laws specifically prohibit such restriction), or create derivative works based on the Software;
- copy the Softw are other than as specified above;
- rent, lease, grant a security interest in, or otherwise transfer rights to the Software; or
- remove any proprietary notices or labels on the Softw are.

DISCLA IMER OF WARRANTY. Software is provided on an "AS IS" basis, without warranty of any kind, including without limitation the warranties of merchantability, fitness for a particular purpose and non-infringement. The entire risk as to the quality and performance of the Software is borne by the Licensee. Should the Software prove defective, Licensee and not FaxProducts assume the entire cost of any service and repair. In addition Licensee must determine prior to purchasing that the Software sufficiently meets Licensee's requirements. Furthermore Licensee must understand that all sales are final and that the Software is non-refundable, nor will licensee receive a refund by requesting a "chargeback" from the credit card company. This disclaimer of warranty constitutes an essential part of the agreement. FaxProducts's sole liability for any breach of this warranty shall be, in FaxProducts's sole discretion:

THIS IS A LIMITED WARRANTY AND IT IS THE ONLY WARRANTY MADE BY FAXPRODUCTS. FAXPRODUCTS MAKES NO OTHER EXPRESS WARRANTY AND NO WARRANTY OF NONINFRINGEMENT OF THIRD PARTIES' RIGHTS. THE DURATION OF IMPLIED WARRANTIES, INCLUDING WITHOUT LIMITATION, WARRANTIES OF MERCHANTABILITY AND OF FITNESS FOR A PARTICULAR PURPOSE, IS LIMITED TO THE ABOVE LIMITED WARRANTY PERIOD; SOME JURISDICTIONS DO NOT

ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, SO LIMITATIONS MAY NOT APPLY TO LICENSEE. If any modifications are made to the Software by Licensee during the warranty period; if the media is subjected to accident, abuse, or improper use; or if Licensee violate the terms of this Agreement, then this warranty shall immediately be terminated. This warranty shall not apply if the Software is used on or in conjunction with hardware or software other than the unmodified version of hardware and software with which the software was designed to be used as described in the Documentation. THIS WARRANTY GIVES LICENSEE SPECIFIC LEGAL RIGHTS, AND LICENSEE MAY HAVE OTHER LEGAL RIGHTS THAT VARY BY JURISDICTION.

TITLE. Title, ow nership rights, and intellectual property rights in the Softw are shall remain in Fax Products and/or its suppliers. The Softw are is protected by the copyright laws and treaties. Title and related rights in the content accessed through the Software is the property of the applicable content ow ner and may be protected by applicable law. This License gives Licensee no rights to such content.

TERMINATION. The license will terminate automatically if Licensee fail to comply with the limitations described here in. On termination, Licensee must destroy all copies of the Software and Documentation.

GOVERNING LAW. This Agreement is made under and shall be governed by and construed in accordance with the laws of the State of New Hampshire, USA, except that body of law pertaining to conflict of laws. The parties specifically agree that the body of law known as the United Nations Convention on the International Sale of Goods shall be inapplicable to this Agreement. Any action hereunder shall be brought in the appropriate state or federal courts of or for New Hampshire, and each party hereby agrees and submits to the personal jurisdiction and venue thereof.

EXPORT. Licensee agrees and warrants that it will not directly or indirectly export or re-export the Software without first obtaining appropriate governmental approvals. Licensee shall indemnify, defend and hold Licensor harmless against any violation of this provision.

LIMITATION OF LIABILITY. UNDER NO CIRCUMSTANCES AND UNDER NO LEGAL THEORY, TORT, CONTRACT, OR OTHERWISE, SHALL FAXPRODUCTS OR ITS SUPPLIERS OR RESELLERS BE LIABLE TO LICENSEE OR ANY OTHER PERSON FOR ANY INDIRECT, SPECIAL, INCIDENTAL, OR CONSEQUENTIAL DAMAGES OF ANY CHARACTER INCLUDING, WITHOUT LIMITATION, DAMAGES FOR LOSS OF GOODWILL, WORK STOPPAGE, COMPUTER FAILURE OR MALFUNCTION, OR ANY AND ALL OTHER COMMERCIAL DAMAGES OR LOSSES.
